NITHYA was born with a hearing impairment which doctors believe was due to a high fever her mother ran in her eighth month of pregnancy. She never let this slow her down.

*"I never let anyone teasing me bother me. Anyway, I couldn't hear them!"*

Four years ago, Nithya's father suggested her taking up a role at VAANI to help other people with speech and hearing impairment get the services they need in order to live independent and fulfilling lives. Since then she has never looked back.

*"Being at VAANI in the role of 'Admin and Supporter Service Officer' has given me a lot of confidence. I want to make sure that I support my team and help build cooperation."*

# ETIKA KHATOON- A STORY OF HOPE



ETIKA Khatoon was born on the 1st of January, 2008 in Sonarpur. She was two years old when her parents observed that she was unresponsive to sounds. After a hearing examination, doctors confirmed that she had profound hearing loss.

Etika registered at VAANI Sadhan Centre on 26 November 2014.

After participating in sessions at the Sadhan Centre, Etika progressed a lot in communication, reading, writing and math skills. Later her family shifted her from a mainstream school to the Calcutta Deaf School and continues to attend sessions at VAANI to help her continue to progress.

Her parents say, "*We are happy to attend the sessions, meetings and training workshops. They help us in understanding many important things required for our child's progress.*"

# REGULAR PROGRAMMES OF WORK



The regular programmes of work involve bringing communication into the lives of deaf children through an Individualised Education Programme (IEP), organizing regular speech training sessions as well as dedicated computer education programmes in Assam, Karnataka and West Bengal. Programme work also focuses in involving parents and family members to enable and enhance their empowerment process.

Providing Life skill education on different topics like good touch and bad touch, healthy eating habits, keeping environment clean, personal hygiene and social etiquette's also form an important part of regular programmes.

# PARENT CAPACITY BUILDING TRAINING WORKSHOPS

VAANI workshops for parents are conducted with the aim of developing the capacity of parents to engage and communicate with their children in a natural home environment. They cover topics such as - What is deafness, Policies available, Parent-to-Parent support etc. and are conducted quarterly across regions. The ultimate aim is to create parent champions who could replicate our work in the community around them.



# THE COMMUNITY EAR CHECK UP CAMP



Under the Community Awareness Programme, free ear check up and audiometry camps were conducted in Bangalore, Tumkur and in Siliguri. These camps are conducted quarterly at different locations to provide access to children who require such services.

# CAPACITY BUILDING PROGRAMME FOR COMMUNITY HEALTH WORKERS



Awareness workshops with the Health and Community workers capacitate them to identify young deaf children and support families with the necessary information and knowledge, thus enabling expectant mothers to minimize risk factors and help families to access the intervention services for deaf children

# AWARENESS PROGRAMME FOR CHILDREN



Under our Awareness and Sensitization programme, VAANI was invited at Indus Valley International School, Bangalore to conduct a session on basic signs. It was an eventful day spent with little ones.



# OUR VISION FOR THE FUTURE



## Parent- Infant Programme- 0-5 Years

The goal of this programme is early screening and Identification of hearing loss in newborns.

Our vision is to create an intervention center with a special educator/auditory verbal therapist who would develop an Individualized Educational Programme for the child and parent.

## Sadhan Resource Centre- 5-14 years

The Sadhan Resource Centre is a space to educate and empower deaf children and their parents to learn and comprehend language and have meaningful conversations.

At present there are 11 Sadhan Resource Centres and in the next five years, the aim is to expand the number in different parts of India, through direct and indirect intervention and in collaboration with partner organizations.



## Youth Transition and Referral Advisory Programme- 14 and above

This is a vision area where the aim is to prepare children for employment or career related educational programmes in association with partners to provide:

- Higher education/career counseling
- Prevocational training
- Vocational training
- Soft skill development
- Advanced life skills

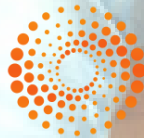

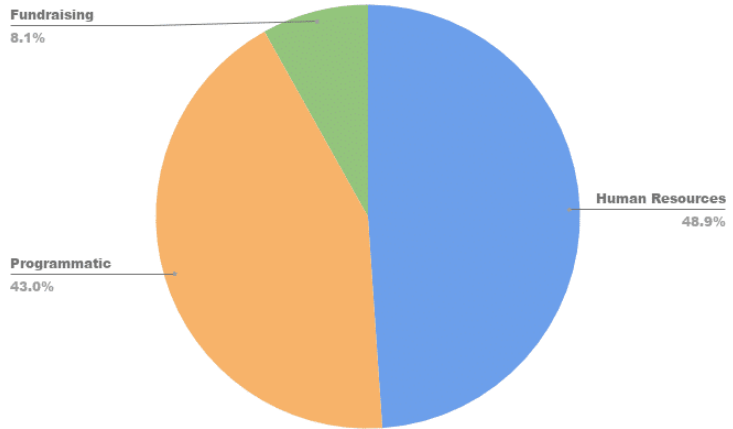

### Opinion

We have audited the accompanying financial statements of VAANI DEAF CHILDREN'S FOUNDATION which comprise the Balance Sheet as at March 31, 2019 the Income and Expenditure Account for the year then ended and a summary of significant accounting policies.

In our opinion and to the best of our information and according to the explanations given to us, the financial statements give us a true and fair view in conformity with the accounting principles generally accepted in India of the state of affairs of VAANI DEAF CHILDREN'S FOUNDATION as at March 31, 2019 and the Excess of Expenditure over Income for the year ended on that date.


