In the past year, VAANI has taken great strides in expanding the reach and scope of its work. We are learning to be creative, inclusive, and on the cutting edge of technology.

We remain committed to empowering the families of hearing-impaired children and to creating an empathetic and enthusiastic environment for every deaf child to find meaningful connections.

## From our Chairpersons Desk:

Hearing loss is the most common sensory deficit in humans today. As per WHO estimates in India, there are approximately 63 million people, who are suffering from Significant Auditory Impairment: this places the estimated prevalence at 6.3% of the Indian population.

Despite the large prevalence of the issue, the systems and facilities for inclusion of the community remain lacking. Right from the screening of newborn babies to the employment of people with hearing impairment, the system is rife with gaps to be filled. Hearing impairment or loss is often neglected as it cannot be seen and, in most cases, the diagnosis is delayed. In India, 1,00,000 babies with hearing loss are born every year. Out of which less than 1% receive a quality education. Each of those children requires a strong community support system in order to be able to flourish.

This is where VAANI comes in. The enthusiastic and highly driven team begins by reaching out to families and children at the time of newborn screening. When children with hearing impairment are identified, both the family and the child are supported with the therapy they require to be able to form meaningful connections with the external world. Though the wins for VAANI are many, the moments we cherish the most are when a child's eyes light up with understanding and being understood.

None of this would have been possible without your steadfast support and we are truly indebted to all the donors, well-wishers, friends, and enthusiastic and dedicated members of Team VAANI.

Over the years VAANI has been able to create a significant impact in the lives of hearing impaired children and their families. We have reached more than 20,000 children, screened around 8000 newborns for hearing loss, and trained 12000+ professionals in the field.

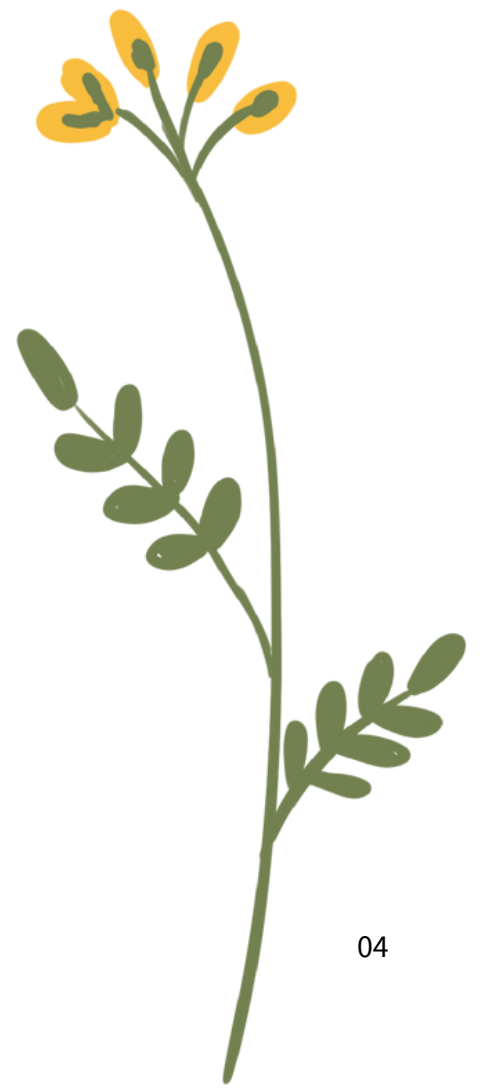

# Our Star Mobilizer

**Biren Kalita** has been a community mobiliser with VAANI since June 2016. Based in Guwahati, he has supported the team by identifying children with hearing impairment through the network of Anganwadi centres in Guwahati.

In 2021-2022, he played a crucial role in enabling VAANI to reach SSA school children in Guwahati through Ear Screening Camps using the "Entraview" device. With his networking abilities, VAANI has screened 2,370 children and 72 adults (which include teachers and school staff) through 44 camps.

Through these camps, the family members of the children, teachers and school staff were sensitised about the need and importance of maintaining ear health. They learnt about how care for the ears can help prevent hearing loss and thus enable the children to enjoy the benefits of the hearing world.

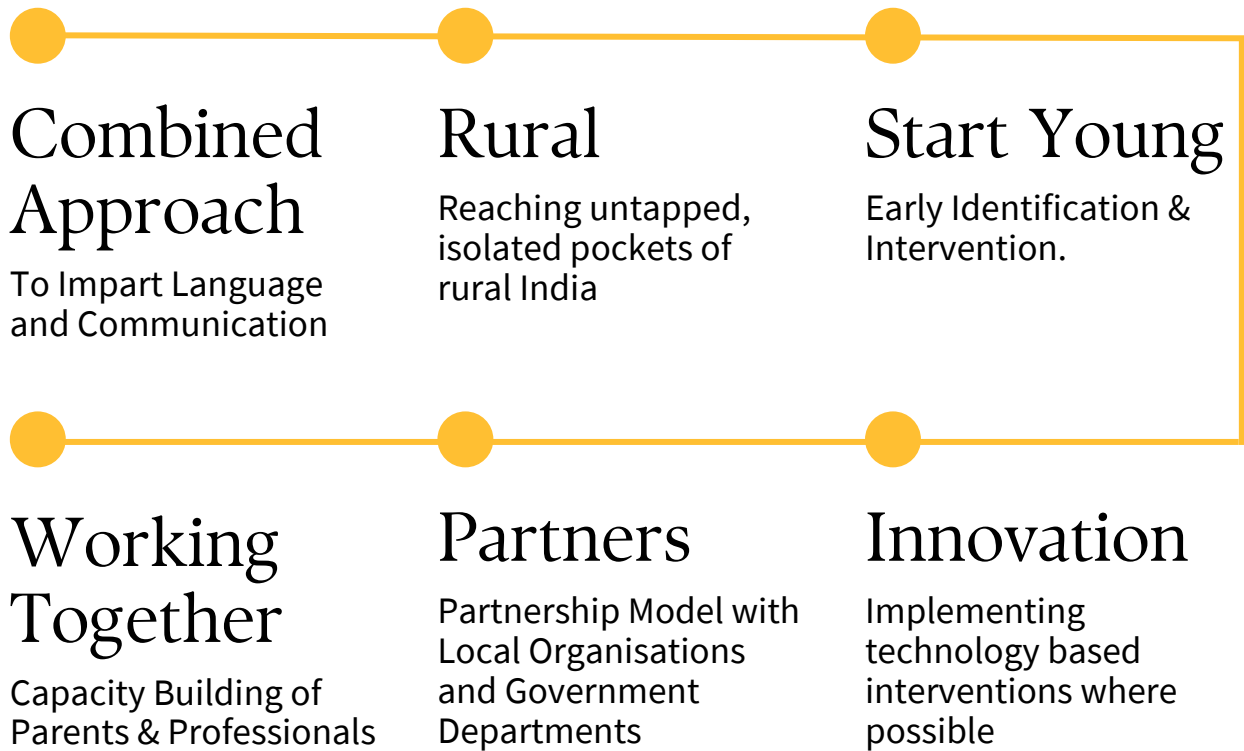

His diligence deserves appreciation and we present him as the STAR Mobiliser of the Year!

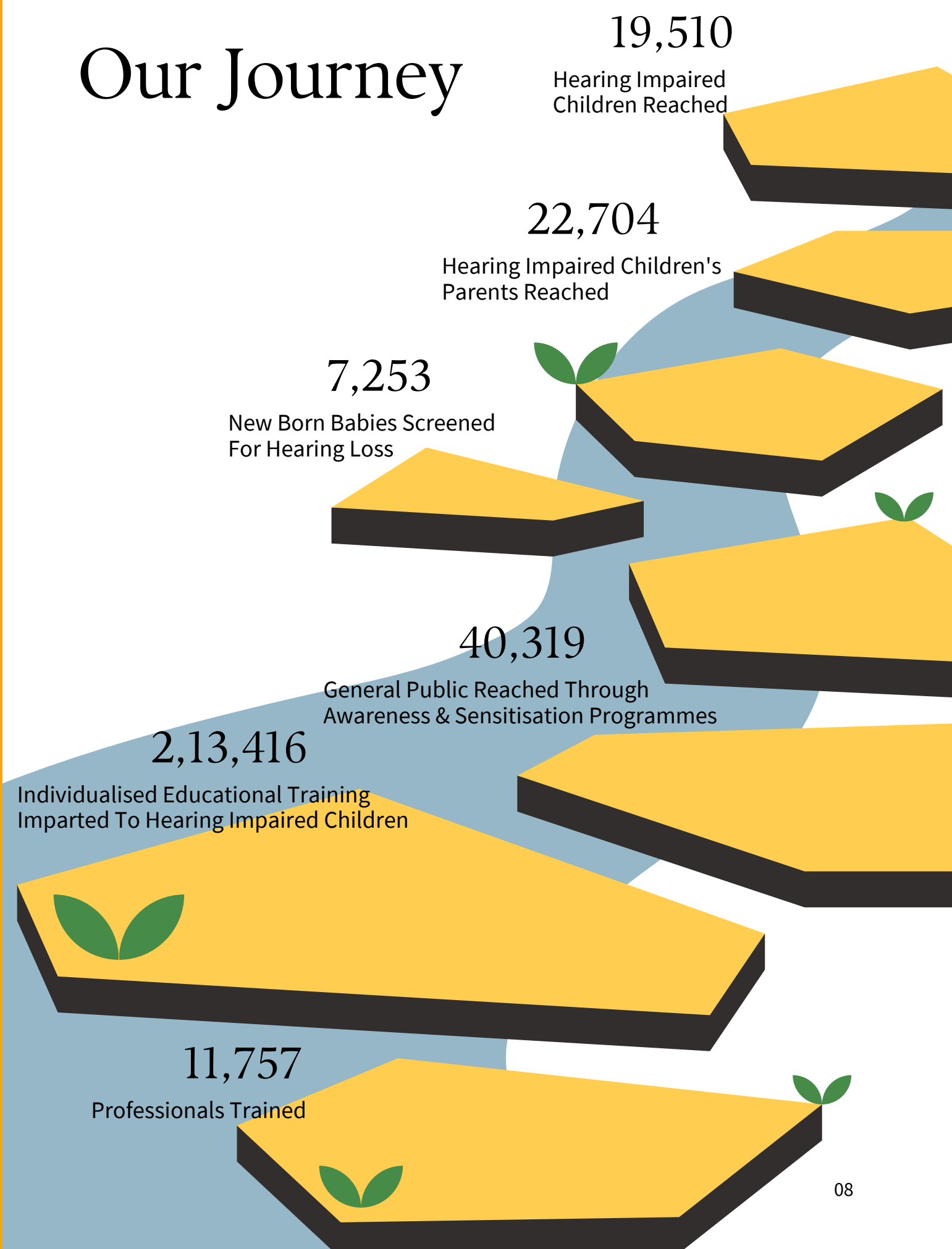

# Our Innovative Methods:

## Exposing children to experiential learning

This year, VAANI continued to push the boundaries of educating children with hearing impairment by introducing experiential learning. This was one of the highlights of the year and enabled children to learn complex concepts by seeing, doing, and feeling things.

A visit to the Science Museum enabled the children to understand what the surfaces of planets such as Mars, Venus, and even the moon and the sun look like! They were also exposed to concepts such as biotic and abiotic elements of The Earth with a focus on how to preserve the Environment.

The most fun part of the experiential learning sessions was when children learned to identify different tastes by experiencing them using their sense of taste and smell! They even got to learn about various colors by using them for art-based activities like doing Rangoli and making cards.



# New Born Screening:

Take a look at our biggest achievements this year:

5,500 Babies have been screened this year with counseling sessions for 5,500 mothers.

We currently have four newborn screening setups in partnership with government hospitals in Tumkur District, Karnataka and Gauhati, Assam.

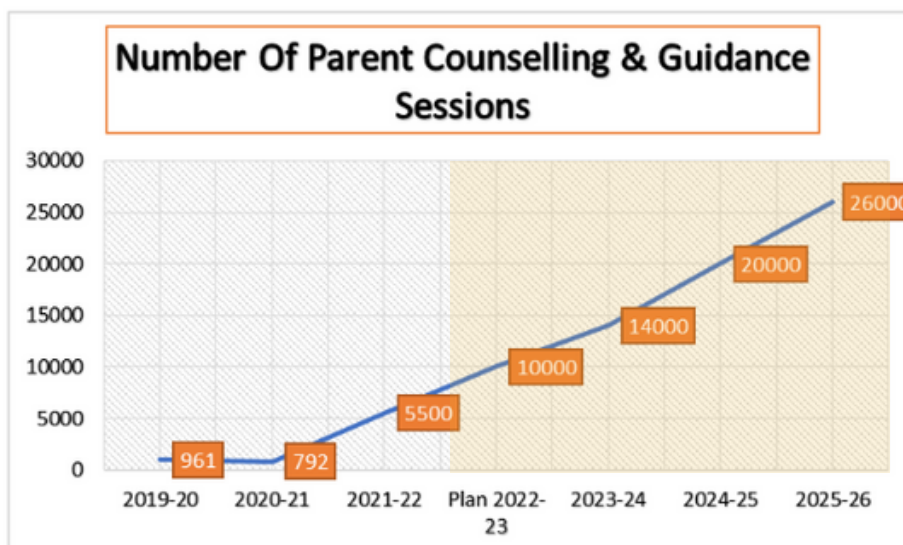
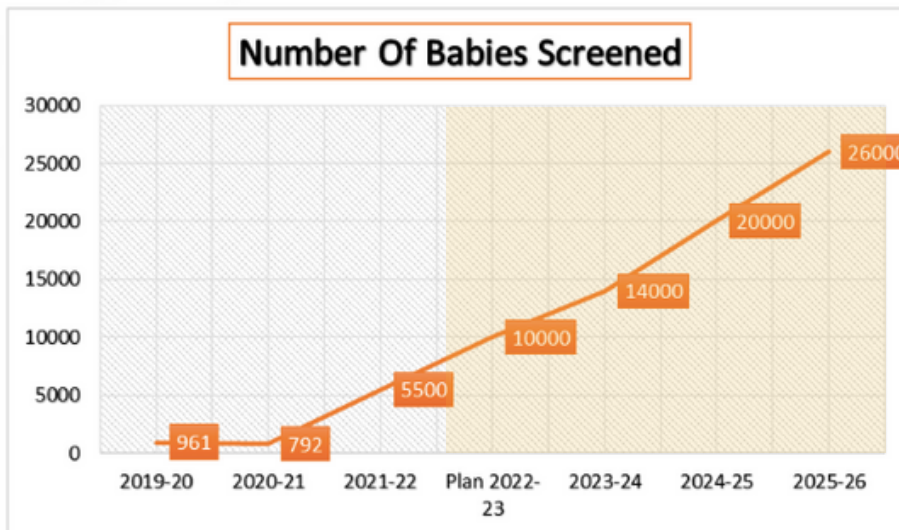




# Newborn Hearing Screening (0-2 years)

## Program and Activity Focus

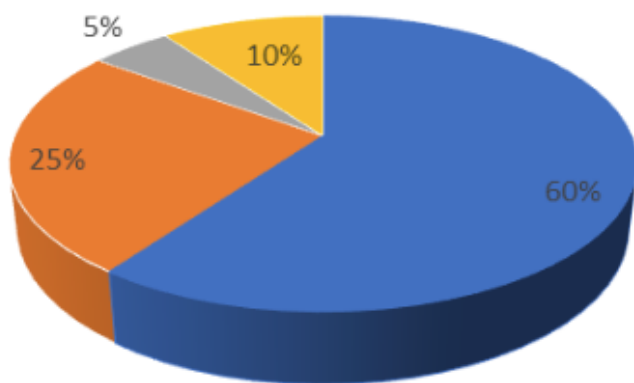
The graph below shows:

From the graph above, you can see that VAANI's program largely focuses on screening newborn babies. This is because early intervention programs work best when children are diagnosed young and are able to seek appropriate support early.

The second largest aspect of the program is creating awareness among family members. When children are first diagnosed with hearing impairment, this can be a great cause of stress to their families, especially their parents. Educating and empowering the family at the earliest stage can be a critical factor in the child's later development. Children that receive more support from their families tend to fare better than those who do not.

VAANI also advocates for more systematic screening of newborn babies and aims to guide healthcare professionals that may be seeking additional information.

# Educational Intervention

Working with children aged between 2 and 18 years old:

592 Children With Hearing Impairment (CWHI) were reached through 20,000 Individualised Educational Assistance both online and offline.

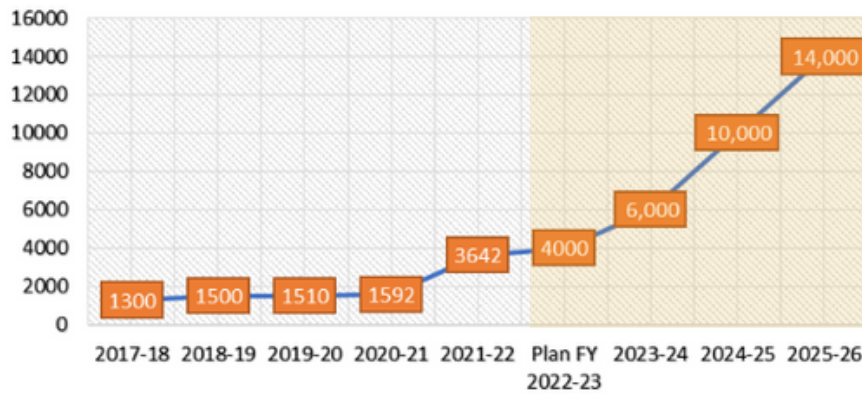
3,050 Children were reached through training provided to educators and interventionists.

We currently have thirteen Sadhan Educational Centres across Assam, West Bengal and Karnataka

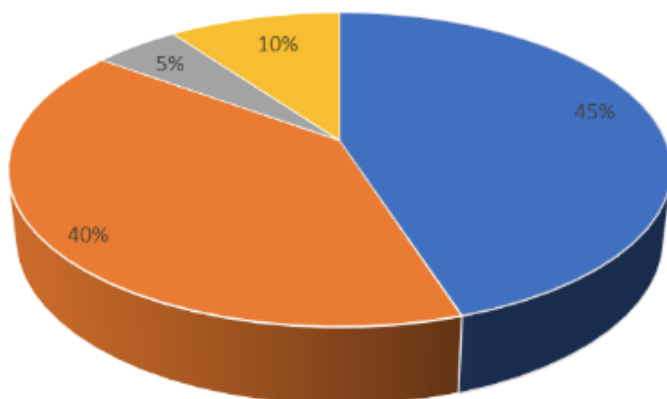
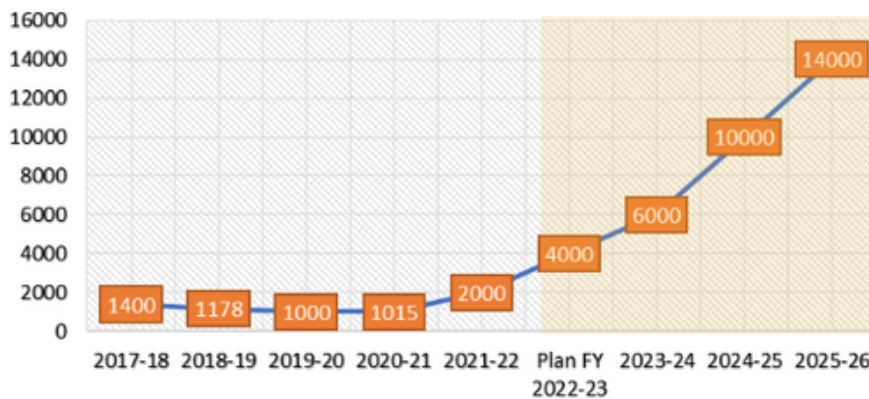


# Educational Intervention (2-18 years)

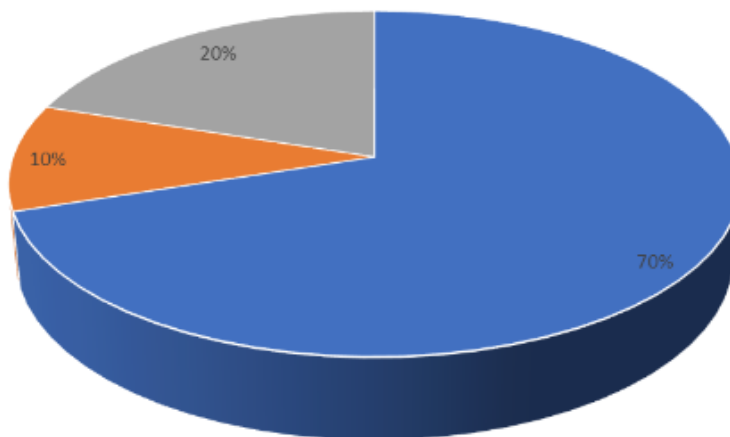
Computer training was conducted for a batch of 95 Children With Hearing Impairment (CWHI) through 2,227 sessions.

VAANI's main focus with the Youth Transition Program is to impart vocational skills to people with hearing impairment. As hearing impaired people grow older, it is critical for them to lead independent lives and for them to be able to contribute productively to society. A part of this program also involves training parents and networking with stakeholders to create further opportunities for people with hearing impairment to access opportunities. VAANI hopes to grow this program significantly in the years to come.

# Parent Workshops



In the states of Assam, West Bengal, and Karnataka around 2,000 parents were reached through training workshops.

Topics covered included the prevention of child sexual abuse, life skills training, and teaching mathematical skills to their hearing impaired children.

Parents learnt what to do if their children get lost, whom to approach, how to write their own names, addresses, nearby landmarks, phone numbers etc. on their children's personal possessions.



They also has sessions where they learnt about how to make teaching mathematics fun.



# Training Workshops for Professionals

750 Sarva Shiksha Abhiyan Resource Teachers from 130 blocks of 34 districts across Assam and Karnataka were trained on teaching techniques for catering to the educational needs of a deaf child enrolled in a mainstream classroom. The focus was on adapting textbooks and instructional material to suit the hearing-impaired child's educational needs. Basic Indian Sign Language and tips to communicate with the deaf were also imparted.





# Training Activities 2021-22: Ensuring Greater reach of VAANI

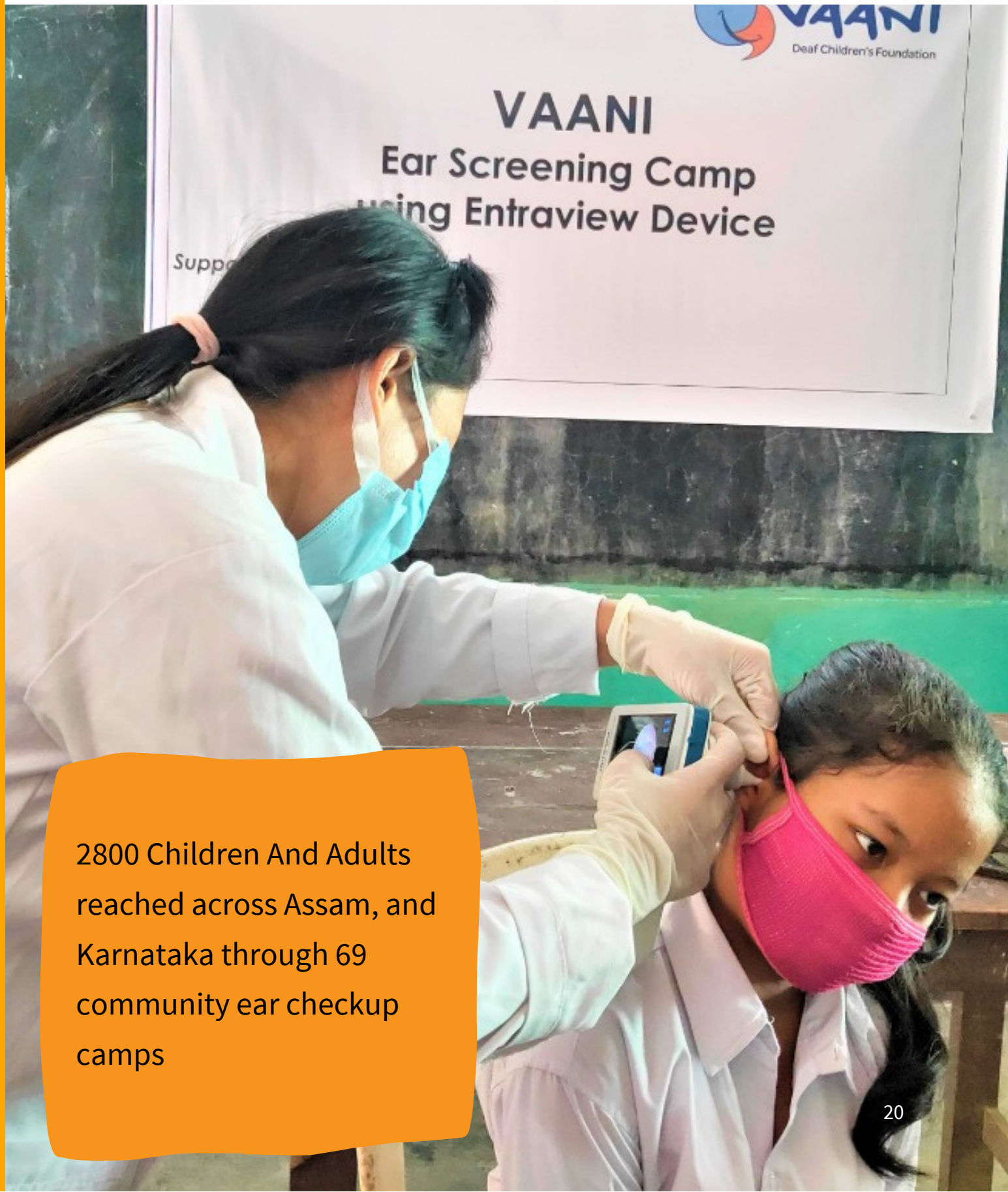
VAANI, Deaf Children's Foundation aims to enable teachers and community-based rehabilitation (CBR) workers to work with deaf children in a way that is both meaningful to them and to the children.

VAANI plans to do this by:

- Reinforcing the knowledge and skills base of teachers and CBR workers through training programs.
- Distributing and sharing teaching materials in regional languages
- Conducting interactive workshops and seminars to update the skills and knowledge of resource persons
- Providing the professionals with an insight into deafness and its impact on the deaf child and their family
- Imparting tips to teachers so that the deaf child could grow to be better adjusted in an inclusive classroom setting and receive education in a barrier-free environment

# Virtual Volunteering

4000 volunteers from Corporates and Educational Institutes were reached through 70 virtual volunteering sessions

## Vaani On Wheels launched on 20th January 2022

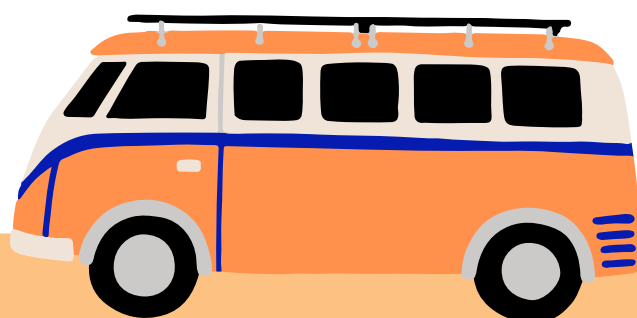

"VAANI ON WHEELS" will allow us to frequently visit the currently untapped remote pockets of Rural Karnataka. The vision of this programme is Community Awareness and Sensitization on the issue Of Early Childhood Deafness, Community Ear Check-Up Camps, New Born Hearing Screening and Educational Assistance to Deaf Children in these pockets. We are extremely grateful to our CSR partner OnMobile for the realisation of our dream.

VOW aim to reach the unreached deaf children, families and communities in different parts of rural and urban Karnataka. The broader aim of the project is early identification followed by immediate intervention for the hearing impaired children at their doorstep and finally achieving the overarching goal of inclusion in the mainstream setup.

The four main objectives of our VOW programme are as follows:

- Community Ear Check-Up Camps
- Mobile Educational Centre
- Early Screening and Identification
- Awareness and Sensitization

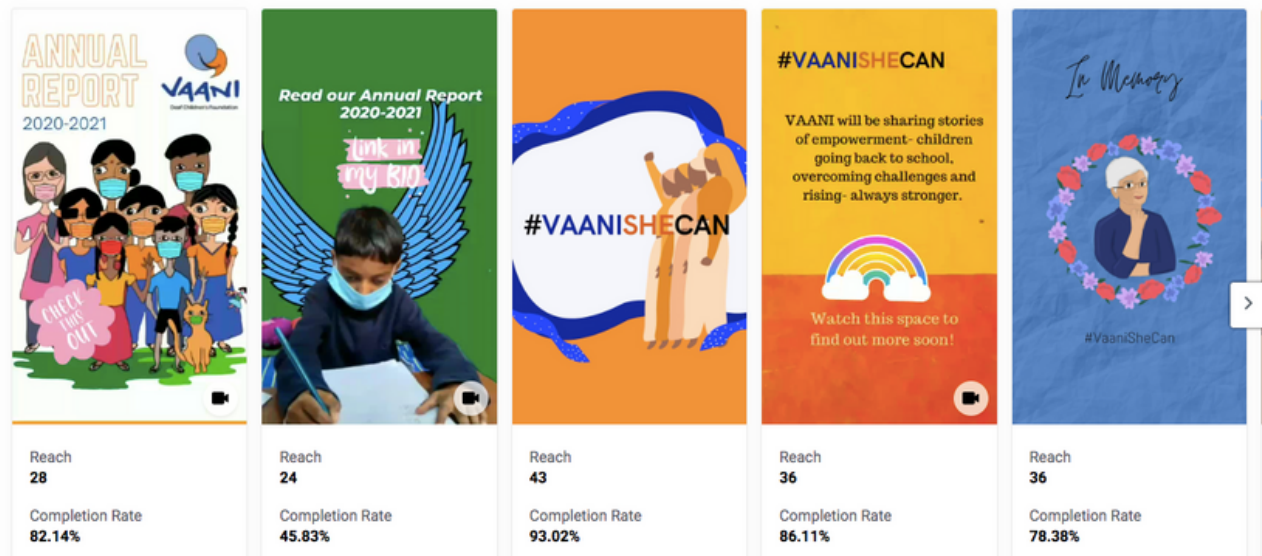

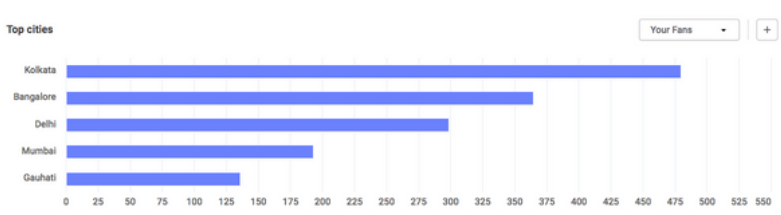

# #SHECAN

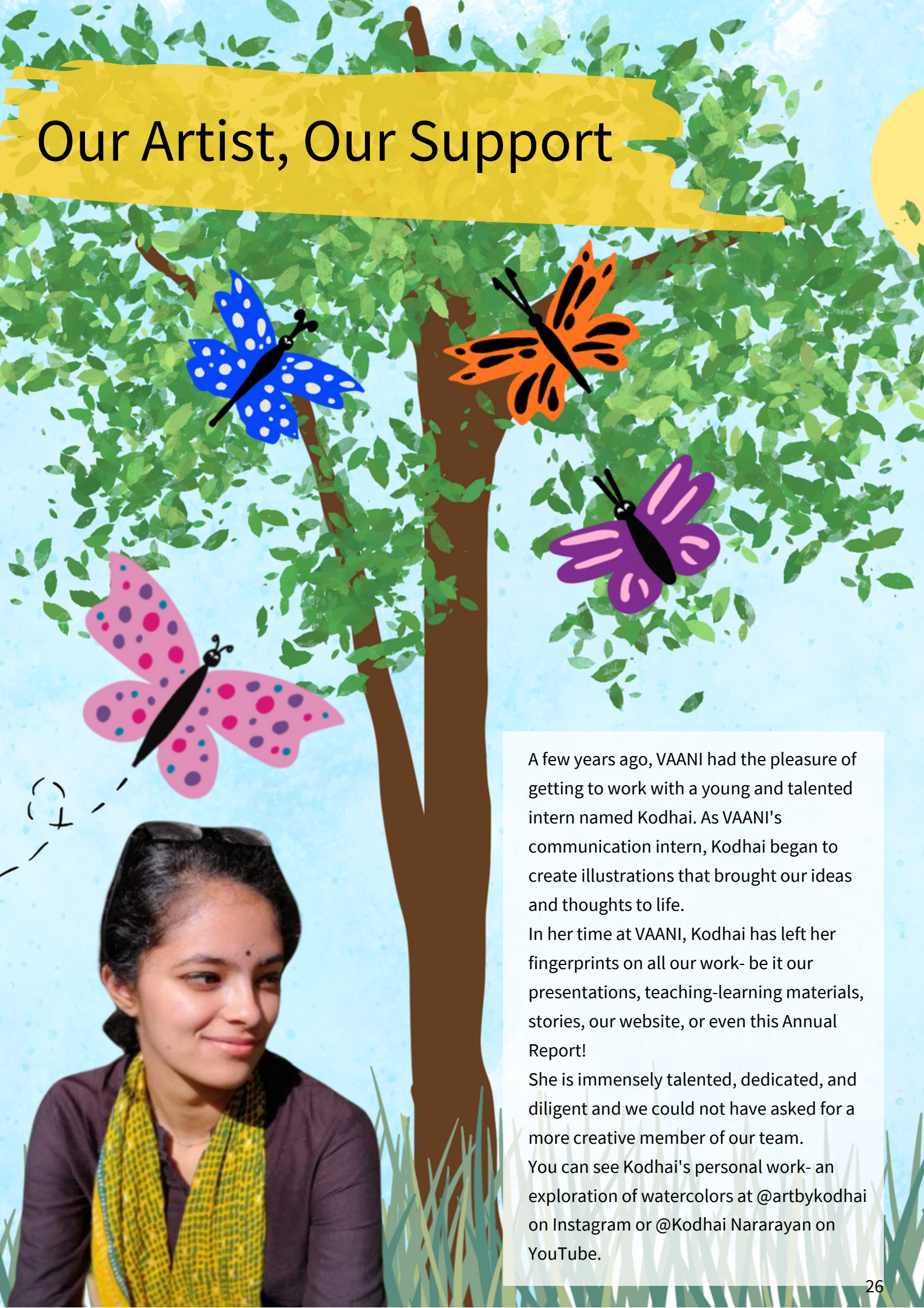
